THE SOCIETY

We record with regret the death of Mr Sleeman, whom many Queens' men will remember as their Tutor or Director of Studies in Natural Sciences. The College owes much to his practical approach to problems, especially where buildings and the interior comfort of rooms were concerned.

His heart was not quite in the Highlands, but very much in the hills and mountains, and it was no surprise to anyone who knew him that he chose the Lake District in which (or, perhaps better, from which) to pass his retirement.

We would express our deep sympathy to Mrs Sleeman on her bereavement. Mr Sleeman has left the College £1,000 for Library purposes.

Professor Sir Harold Bailey is to be presented with the Triennial Gold Medal of the Royal Asiatic Society for services to Oriental Studies.

Professor Beament has been elected to a Fellowship by the Royal Society of Arts, for contributions to the application of science or technology to the Arts. This is a happy moment to recall his election to the Composers' Guild of Great Britain a few years ago; audiences at recent May Concerts will know why.

We have with regret, but with congratulations to them, lost Mr King to the Ford Foundation, Dr Watson to the University of Glasgow, Dr Ginsborg to York and, just as we go to press, Dr Platt to the Chair of Latin American History at Oxford. Changes of College Office are recorded in the list of Fellows, and we also welcome as new Fellows Dr Van Arkadie and Mr Pountain (whose Research Fellowship will be cut short all too soon by an appointment at Nottingham).

Special reference should be made to the change of Senior Tutor, to which Office we welcome Dr Machin. His predecessor, Dr Bull, held office for many years and generations of Queens' men owe much to his ready counsel and to the care that he was always anxious to give to individual problems. Himself a Queens' undergraduate, like his successor, he has always put College matters to the forefront of his attention, and we are all grateful to him.

The death of Bishop Chase, Honorary Fellow, has left a real

gap in the life not only of Queens' but the University generally. Despite other claims upon him from Selwyn, where he had been Master, he regularly supported this College and was a familiar figure at many of our gatherings.

Sir Leslie Rowan, Honorary Fellow, is now Chairman of the British Council.

BEQUESTS

Mr Sleeman, Fellow of the College, bequeathed the sum of £1,000, to be paid on the death of his wife for library purposes.

His Honour Judge Norman Carr bequeathed the sum of £1,000, Mr R. W. V. Robins left £100 for the Building Fund, Mr W. E. Blackwood bequeathed the sum of £2,000 and Mr B. S. Collins (1915) left the College the sum of £300.

In memory of their late brother Sir Charles Howell Thomas, Miss E. G. Thomas left £100 and Miss C. E. Thomas left £6,000.

Bishop G. A. Chase, Honorary Fellow of the College, bequeathed the sum of £500 for general purposes.

GIFTS

Professor T. Bergin, a visitor from the Law School of the University of Virginia, on leaving Cambridge made a gift of £25 to be used for Combination Room purposes.

Mrs Barbara Gould has given to the College two portraits of her ancestors, the Rev. William Byatt and his wife Dorothy. Mr Byatt was a Fellow of the College from 1698 to 1704.

MR AUBREY SIMMONS

Mr Aubrey Simmons retired from the Buttery staff on 5 November 1971 after 47 years in the College service, having joined under Mr Chamberlain in 1924. He and his wife have moved away to live in Bedford and we wish them a long and happy retirement.

THE FABRIC

The building site for the new College development is surrounded by hoardings which, save for an observation window, conceal the scene of devastation which always marks the early stages of any new building. Hopefully, by the summer there will be signs of the new buildings rising from their foundations. The valuable topsoil from the Fellows' Garden has been jealously kept, piled in the Grove for use in making the new lawns and gardens which will be a prominent feature of the new building. Meanwhile, a great deal of work is being done on plans concerned with both the new buildings and the Old College; the principle is accepted that the Old College must also benefit from the new development. Thus, for example, plans are already being made for the restoration of Pump Court to its former beauty.

Repairs and improvements have been made to the exterior and interior of the President's Lodge, and the Lodge has been completely re-wired; the President and his family took up residence in College during April 1971. The Old Library has also been re-wired and is now being redecorated. Excavation of the basement of Dokett has been extended, and the College Office now has a room below ground level for the storage of records. The central heating system on the east side of the Cam has been enlarged to include G and H staircases. The plaster which supports the Sundial in Old Court has had to be removed and replaced, and the Dial has been faithfully restored and repainted with all the errors that it has accumulated over the centuries. An additional coin-operated telephone call-box has been installed at the corner of Dokett and Friars Buildings.

This room has now been converted into a Reading Room and Law Library. The whole of the Law section has been placed here, and a complete set of the All England Law Reports has been bought.

During 1970-71, the Council of the College Union was chiefly concerned with two matters: the question of reform of the meals system and the formulation of a revised constitution for the Union itself.

On the meals issue, considerable consultation took place with the Governing Body over various schemes which were suggested, and it is pleasing to note that the main recommendation, namely the institution of a meal-ticket system of payment, has since been introduced.

In administration, it was quickly realised that the existing constitution was too vague on several important issues and was riddled with loopholes. The Council set up a sub-committee to consider a reformulation of the constitution and their draft document was approved by the Council, then by a Special General meeting of the Union.

Besides the two major issues, the Council discussed various other matters, including the new building and the situation of the squash courts.

This was a year of ups and downs. The season started with the University Fours Races, in which both our Light and Clinker IV's were beaten in the first round. Thereafter four members of the club entered for the University Trials, but all dropped out before the end of term except N. G. Hughes, who went on to cox the Blue Boat for the second year running. It is worth mentioning at this point that N. G. Hughes was elected at the end of the season to be President of the C.U.B.C. (a rare honour indeed for the Cox) to be the first President from Queens'.

The Fairbairn Cup Race forms the climax of the Michaelmas Term, in which we rose twelve places from 23rd to 11th.

The programme for the Lent Term is always planned with a view to the Lent Bumps. During the term however we had a disappointing row at London Colleges Regatta, followed by a much more commendable effort in appalling conditions at Peterborough Head of the River, where we came 2nd out of a large number of entries. The outcome of the Lent Bumping Races shows the variable nature of the crew's performance: on the first day we bumped L.M.B.C.; on the second day we just failed to bump Fitzwilliam, but managed to get them on the third day. On the final day we rowed over, missing Clare by a very small margin, thus finishing in 5th position. For some years, Queens' has not sent a crew to the Tideway Head, and we decided to do so this year. The week spent in London was generally cold and wet, but we coped with these conditions well. Our final position in the Head Race was 39th.

The crew remained the same for the Easter Term. In the Mays we were bumped on the first night by an extremely fast 1st and 3rd crew; on the second night we were disappointingly bumped by Pembroke; on the third night we rowed over, and finally on the Saturday we bumped L.M.B.C., thereby finishing in 7th position. After the end of the term, we spent a valuable and enjoyable fortnight at Henley, keying ourselves up for the Regatta.

In the qualifying races we beat Exeter University, but then unfortunately came up against, and lost to, London University, who went on to win the Ladies' Plate.

The 1970-71 athletics season was a poor one for the college as a whole, but as regards the achievements of individual athletes it was very satisfying.

We easily won the first round competition of Cuppers against Magdalene, Pembroke and Downing, gaining ten first places out of a possible fifteen – this was due to a large and enthusiastic turnout by the Cross-Country runners of the College. Athletics Blue C. J. Garforth produced the best performance of the day by winning the 5000 metres in the excellent time of 14 min. 57.8 sec., despite a very cold strong wind. Unfortunately, our hopes of gaining promotion to Division 1 were dashed by the clash of a Cross-Country race with the Division 2 final, and so we were able to field only a token team against Clare and Corpus. Nevertheless our few athletes competed commendably and the final points position was as follows: Clare 115, Corpus Christi 111½, Queens' 88½.

Our intake of freshmen athletes was very meagre, but W. G. Fulford established himself as a competent 1500 metre runner by gaining selection in that event for the Freshers' Match against Oxford. In the annual track and field matches against Oxford, C. J. Garforth and R. G. J. Ward, represented the University on the track, and G. R. D. Tudhope competed in the Long Jump.

Athletic activity was resumed in April when D. J. Abrehart, M. J. Danielewski, W. G. Fulford and R. G. J. Ward represented the University regularly in the various first and second team matches which were used as a basis for the selection of the Blues and Alverstone teams to meet Oxford in May. Consequently R. G. J. Ward ran first string in the 1500 metres for the Blues team, and M. J. Danielewski and W. G. Fulford filled the Alverstone team places for the 1500 metres. Also representing Alverstone were D. J. Abrehart in the 3000 metres Steeplechase and G. R. D. Tudhope in the Long Jump. Rees Ward completed a fine year by representing the combined Oxford and Cambridge teams against Harvard and Yale at Crystal Palace in June.

The Easter Term concert (the May Week concert) was performed as usual in Hall, and included works by Arnold, Britten and Cordy, culminating in the first vocal appearance of the Classical Society, under the baton of Dr James Diggle, and a rousing performance of Bach's Peasant Cantata by the St Margaret Society May Week Chorus and Orchestra, conducted by Christopher Pountain.

The Society organised many other concerts throughout the year, held largely in the Chapel by kind permission of the Dean of Chapel and the Governing Body; Martin Oinn gave three lieder recitals, including Schubert's *Winterreise*, and songs by Fauré, Vaughan Williams and Poulenc; Charles Cordy, Richard Carver and Stanley Monkhouse organised numerous chamber recitals, and David Charlton took over the J.C.R. on Saint Valentine's Day (which fell conveniently on a Sunday) to organise a Smoking Concert at which not only were world premières of musical works given, but also mulled wine was served to lend a touch of frenzy to the proceedings. The previous Organ Scholar, Richard Hickox, appeared in the College during the Michaelmas Term with his chamber choir, the Wooburn Singers, and gave a concert in Chapel, including in his programme: *Lord thou hast been our refuge*, Vaughan Williams; Alto Rhapsody, Brahms; three motets

by Gibbons, Walton and Weelkes; Theresa Mass, Haydn. The present Organ Scholar, John Clough, arranged a series of Organ Recitals in the Chapel at which audiences were at first a little tentative, but the large increase in numbers during the year showed the growing appeal of these recitals, which were invariably of a very high standard.

The Society performed concerts outside Cambridge on two occasions; once in Histon, where a charity concert was organised in the local church, and once in Richard Carver's home village, where an ambitious concert was extremely well received. In Cambridge, too, the Society was not content to remain within the confines of the College, but following the precedent set by the previous Organ Scholar, moved into town to perform its Lent Term Main Concert, the Mozart Requiem. It is hoped to continue this tradition in the future, and already plans are being made to perform the Brahms Requiem in the Guildhall in the Michaelmas Term 1971. In fact, the Society now operates on such a scale that it is second only to C.U.M.S. in size, with a chorus of about 200, of whom almost half are College members; ever-faithful Homer-ton continues to provide the majority of the ladies who sing with us, for which we are very grateful.

The extraordinarily successful Cambridge run of our 1970 Swedish Tour play *A Midsummer Night's Dream*, at the very begin-

ning of the Michaelmas Term, set a note of optimism which persisted throughout the year. Despite a shortage of producers, there was no lack of new acting and technical talent and of helpers anxious to undertake small projects such as experimental play evenings or the establishment of an adequate basic wardrobe.

An unfortunate plague of indecision led to the Freshmen's Main production being a double-bill of one-act plays, Ionesco's *The Bald Primadonna* and John Whiting's *No Why*. Although only modest successes, these were greatly enjoyed by all involved; the same can be said of the Lent Main, a modern and idiosyncratic translation of Molière's *Le Misanthrope*.

During this time other activities were keeping the idle occupied: one group collaborated with The Chapel Players, with the encouragement of the Dean of Chapel, to produce a version of *The Woman taken in Adultery*. Another close-knit band under the direction of Neil Rae spent the winter shooting a melodramatic silent film which is now almost ready for presentation. Less artistically, but very profitably, the Technical Director managed to foster a huge increase in the hiring-out of BATS equipment.

The summer saw a Cloister Court production of *Romeo and Juliet*, which succeeded despite the perversity of the weather (the first night's show had to be transferred to a May Ball marquee in pouring rain – all credit to a very dedicated technical crew!) and the numerous other commitments of the producer, John Newbigin.

Lest anyone was hoping for a restful summer after this, it was decided to repeat last year's success and return to Sweden under the auspices of the Stockholm Skolsteater. The play chosen – *The Happy Haven*, by John Arden – was received with great enthusiasm, if not total comprehension, by the Swedish schools, and managed to collect itself a fan club, who subsequently sent photos and letters of great nostalgic value to the Tour team.

In all, a year of moderate artistic success notable chiefly for the emergence of an astonishing esprit de corps, evident in every BATS activity and promising a highly successful year for 1971-72.
