THE PRESIDENT

We congratulate the President on the high honour conferred on him by his election as Vice-Chancellor of the University of Manchester, which has also conferred on him the Honorary Degree of Doctor of Laws. But Queens' will miss him greatly, both on personal grounds and for the guidance that he has given to all the many-sided business of the College. To him and to his family, especially to Mrs Armitage for her devoted service to the Lodge, go the best wishes of all of us.

THE SOCIETY

It has been in many ways a good year, with the election to a Professorship in the University of Dr Ramsay, and the weddings of Mr Hart, Dr Baldwin and Dr Middleton; Professor Knights has received an Honorary Degree from the University of York and Professor Chadwick, Honorary Fellow, is now Dean of Christ Church, Oxford.

Leave of absence has been granted to Mr Hughes to attend Council Meetings of the International Palaeontological Union in Prague, and to Mr King to work with the Population Division of the World Bank for the period August 1969 to July 1971. Prof. Knights and Mr Singh have been granted leave of absence for the Easter Term, 1970. Mr Morgan is intermitting his Research Fellowship for one year as Assistant Professor at McGill University.

We welcome Mr Wright as Research Fellow in English, Mr Eatwell as Research Fellow in Economics, and Mr Green as Bye-Fellow in Mathematics. Dr Hayhurst, C.E.G.B. Research Fellow, has been elected to an Official Fellowship as from 1 September 1970, and will fill the newly created office of Assistant Bursar from that date. Mr D. B. Sattelle has been elected to a Research Fellowship in Natural Sciences (Zoology) as from 1 October 1970.

We have parted regretfully with Mr Mogridge, now Professor at Carleton University, Ottawa; Mr Pearl on his election to a Fellowship at Fitzwilliam College, and Mr Tillett who has left us on taking up an appointment in the City.

It is with deep regret that we record the death of our Honorary Fellow Bishop Hannay, who had been Bishop of Argyll and the Isles and Primus of the Episcopal Church in Scotland.

THE FABRIC

Work completed during the last twelve months includes the conversion of the entire College from 200 to 240 volt electrical supply, and from town to natural gas. Both conversions were achieved with not more than the expected number of difficulties, but the unfamiliar properties of natural gas continue to present problems that have not yet been fully overcome.

New structural alterations include the conversion of the ground floor of the Fitzpatrick Hall into a College bar, the building of a larger and more fully equipped laundromat in the corner of the College between Friars and Dokett, the excavation of yet more of the basement of Dokett to provide space for new changing facilities, the installation of a third main boiler in the old changing room at the north end of Dokett basement, and the elimination of the steps on the path up the centre of Cloister Court.

The two rooms at the top of Erasmus Tower, previously occupied by Fellows, have been refurnished so that the smaller, I3, has become an additional overnight guest room, and the larger, I5, a room which can be used either as a formal dining-room for up to 12 people or as a seminar room for up to 20 participants.

Mr Cook, who has wound and maintained the College clocks for 50 years, has been compelled to retire through ill-health. His successor, Mr Apthorpe, is learning the idiosyncracies of the various timepieces.

We regret an error in the Record for last year. The Bible for use in the Chapel was presented by Dr Silk, who was a Research Fellow from January 1967 till October 1968.

The College has also received from the American Friends of Cambridge University a further donation of \$,000.

By the end of its first year of operation the Union had accomplished a great deal. After much consultation it had been decided to initiate a College bar, which was to be installed in the Lower Fitzpatrick, and by October 1969 the job was completed and the bar in operation. It has proved to be a great success. Under Union auspices new laundromat facilities were built, as the old laundrette had become hopelessly inadequate. These were the major tangible results of the year, but other changes, such as a relaxation of rules concerning entry and exit from the College, were also effected. United Clubs finance is now under the control of the Council of the Union, and the new system is running smoothly. Throughout the year undergraduates on the Council of the Union have learnt a great deal about the problems involved in running the College, and through the undergraduate representatives contact between senior and junior members was increased. There is still much room for improving the system and enhancing further communication, but it seems that the Union has got off to a good start.

The 1968-9 rowing season began with the University IVs Races. The Light IV was very promising from the beginning of training, but was beaten in the second round by a fitter Clare crew. The IV produced two University Trialists, C. J. Dalley and M. G. Ward. Both also rowed in the successful Goldie crew. The Clinker IV entry, which contained two freshmen, was upset by injury just before the races and was beaten by Downing in the first round. Declining Boat Club membership seriously weakened the two Fairbairn crews in training. The two crews fused to become a highly unsuccessful one. The Novice Boat returned creditable performances in the Fairbairn Races and Novice's Regatta.

The Lent term proved to be disastrous. Ist VIII selection from an inexperienced training squad provided a crew containing four freshmen, two of whom were novices. Although lacking experience, the crew improved during term. At Peterborough Head Race, the VIII finished third over all, being the fastest restricted boat. Illness took two of the more experienced members from the crew. The boat never recovered from this change and lost four places in the Lents. The 2nd VIII lost two places and a Gentlemen's Boat, performing a Third Boat, lost four places. At Bedford Head the 1st VIII finished eleventh while at Reading we were not so successful.

Strengthened by the return of the two Goldie oars, the 1st May Boat was much improved. Finishing eleventh in the Head of the Cam was disappointing, but not discouraging. Good coaching improved skill, fitness and confidence to produce a fast May Boat. A superior Fitzwilliam crew deposed Queens' from Head on the first evening. Second place was retained, the only serious challenge coming from Trinity. The 2nd VIII won its oars easily. Gentlemen's Boats were in general not over successful. The Henley VIII consisting equally of 1st and 2nd May Colours was beaten by

Imperial College. A IV from the VIII took revenge by beating Imperial College in the first round, but was beaten in the quarter-final by Clare, mainly because Queens' seemed incapable of avoiding the booms.

Queens' finished in the middle of the League table with four wins and one draw out of nine games. The first four games went badly due mainly to a lack of weight and size in the forwards and lack of penetration in the three-quarters. As the term went on the forward play improved and with a style of play based on close forward interpassing, the results also improved.

W. A. Jones, J. J. Page and J. S. Spencer represented the University against Oxford and G. L. Prescott played for the LX club throughout the season. J. S. Spencer was elected Captain of the University and also played for England in all four internationals.

In the Cuppers competition in the Lent term, Queens' had a comfortable first-round victory over Sidney Sussex. Victory in two closely contested games against Emmanuel and Selwyn took Queens' to the final for the second year in succession. In the final against a very strong St Catherine's side, Queens' went down 9-12, all Queens' points coming from the boot of J. J. Page.

What was at first regarded as only an average Queens' side proved eventually to be one of the strongest, if not the strongest side in the University. After an excellent win over the reigning League Champions, Christ's, on their own ground, Queens' acquired the self-confidence that played a major role in their success. With 15 points from 9 matches, Queens' finished second in the League, being beaten on goal average by St John's. The championship was lost in the final match when we were held to a 2-2 draw by St Catherine's whereas a win would have given us the league title.

For Cuppers, only John Rowlinson came into the side from the Falcons. After two replays against Christ's, Queens' easily beat Downing but were again taken to a replay in the semi-final by Emmanuel: Queens' won 3-0. The final against Fitzwilliam saw Queens' playing their 7th game in 11 days. An exciting game with mixed fortunes for Queens' ended in a 3-3 draw, after extra time. As for the batting, it proved to be reasonably consistent, but there was a lack of flair for scoring runs quickly and under pressure. M. Bawden topped the averages with 33·67. The team could do with one or two stroke-making batsmen for the 1970 season.

Over the last twelve months the Athletics club has been characterized by a surprising lack of balance between its two sections. On the one hand the cross-country runners have proved them-

selves the strongest team of any of the Cambridge colleges, while track athletics has suffered from neglect and lack of enthusiasm.

In October 1968 the already strong cross-country team was enlarged by four freshmen, one of whom, Chris Garforth, was to prove a tremendous asset to the Club and was later to become National Youth Champion. Queens' was thus able to turn out around a dozen runners for each of the four matches of the Inter-College League. Only in the third of these was there any doubt that Queens' might not win, since St John's was also a strong contender for the championship. However, as it turned out, Queens' was victorious by quite a convincing margin, largely because our large squad of runners helped to push down the opponents' lower points scorers. This win had already been foreshadowed by our victory in Cuppers, the inter-College Race, where the small margin of 22 points gained us the trophy from our rivals, St John's.

Queens' were equally successful in the season's road relays. We won the Selwyn road relay, establishing our superiority in a four-man team event over both the Oxford and Cambridge colleges. Excellent results were also achieved in the Borough Road and Imperial College relays, where most of the Universities compete. We managed 12th and 13th positions respectively—no mean feat for a college as small as ours—thanks largely to the excellent running of Mike Turner, who pulled us up several places on both occasions. The final touch, in this most successful season, was winning the Hare and Hounds Club Cross-Country relay, which meant that Queens' had won all the Cambridge inter-college events. Furthermore, we were able to look forward to the following season with the prospect that, since none of our runners were leaving, our team could only be strengthened by any freshmen joining us this year.

Unfortunately, this wave of success was not carried onto the track this summer. There was little response from the members of the college to the desperate efforts of Chris Garforth and Pete Spencer to fill all the events. Through lack of support we found ourselves beaten into third place in the first round of Athletics Cuppers and threatened with demotion to the second division in the Losers' Final. When this became known we were suddenly

swamped by offers from prospective athletes, but although we filled all the events this time, a close struggle with Trinity ended in our being demoted none the less, by a margin of a dozen points. Yet, as had been shown, Queens' is capable of fielding a large number of useful athletes, and must possess many more who were not forthcoming. It is to be hoped that next October this situation will be remedied, and that Queens' will fight its way back into the first division where it belongs.

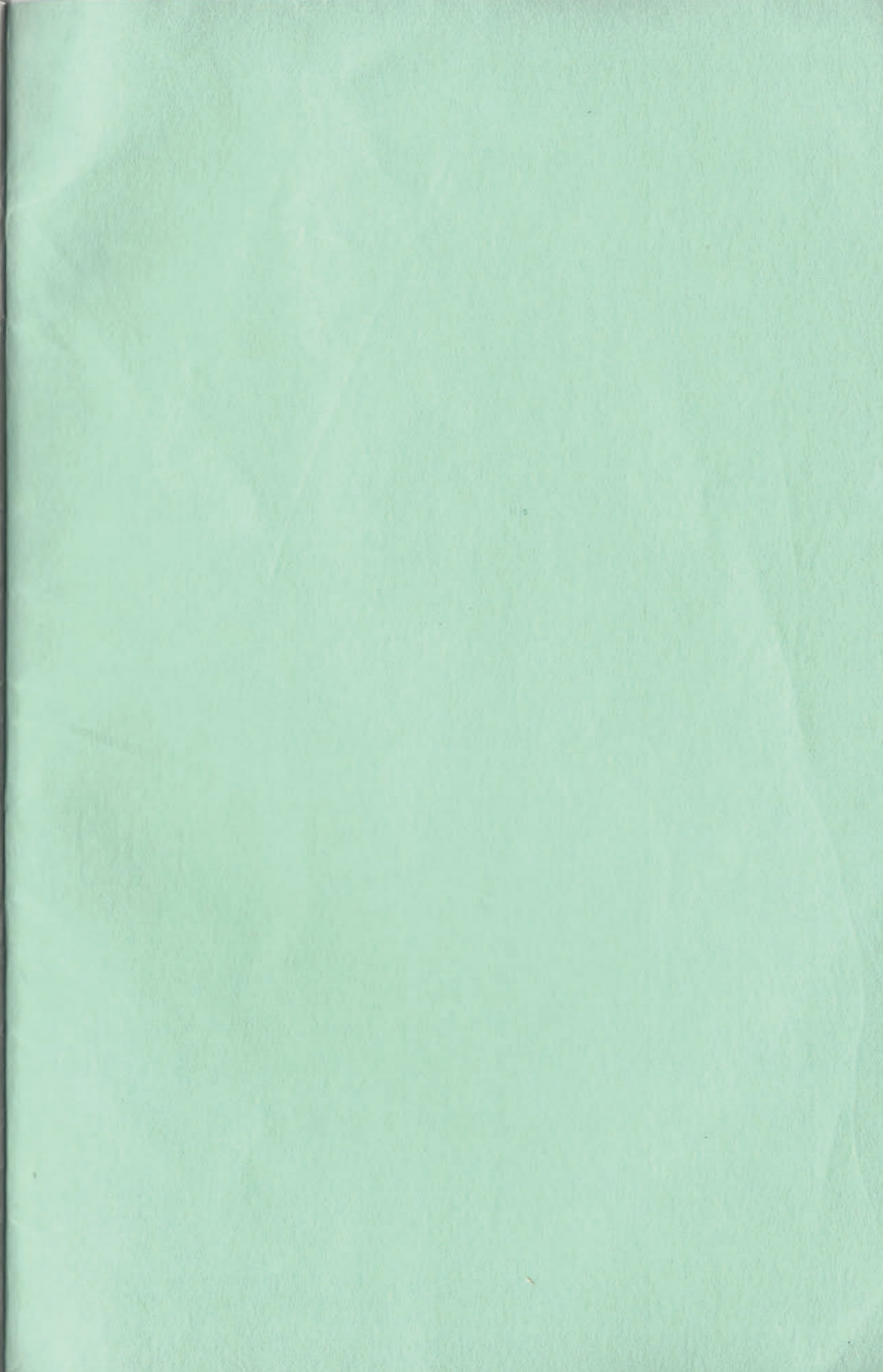
